# Subdivision and Land Development Review Committee Report

There are a total of ten (10) plans submitted for April.

- Seven (7) Wright Land Surveying, one (1) Meck-Tech, Inc., One (1) PennTerra Engineering, Inc., one (1) Charles M. Colony
- Ten (10) plans are under municipal ordinance.
- Four (4) lot additions, one (1) minor subdivision/non-residential land development, one
  (1) lot minor land development, three (3) minor subdivisions, one (1) minor residential land development.

The plans are for Take 5 Oil Change (Granville Township), Belleville Storage, John Smoker (Union Township), Ivan & Elsie Kauffman (Menno/Union Township), Nancy Hostetler (Armagh Township), Travis & Faith Brehman (Decatur Township), Stephen & Kristen Alexander (Derry Township), Christie & Verda Peight (Oliver Township), Richard & Helen Harshbarger (Oliver Township), Sylvanus & Ida Peachey (Union Township).

# **Municipal Subdivision Plans**

The committee members reviewed four (4) of the ten (10) submitted plans. Lettiere did not go over any details of the projects but requested the planning committee members allow for the remainder of the plans to be completed by the 30-day allowance, which is May 1<sup>st</sup>, 2024. Dunmire ask for a motion for the extension. Pennebaker made a motion and Campbell seconded it. All voted aye. Semler ask for a correction of a date in the Take 5 Oil review letter. The members gave approval of the comments for the four plans reviewed, for the correction, and permission for the balance of plans to be completed by the 30-day allowance.

The Allensville Streetscape project is scheduled for a meeting on May 22<sup>nd</sup>, 2024.
