2024 PREA Annual Report

The Prison Rape Elimination Act (PREA) was passed by Congress and signed into law by President George W. Bush 2003 to prevent, detect, and respond to sexual abuse that occurs in confinement settings. The act became final in June of 2012. The Mifflin County Correctional Facility has zero tolerance for sexual abuse or sexual harassment of any individual under the supervision of the MCCF.

Every allegation of sexual abuse or sexual harassment will be investigated thoroughly and promptly by the Lewistown Police Department. Victim Advocate Services are offered to the victim regardless of whether the investigation is unfounded, unsubstantiated, or substantiated.
