D. Assignment of PA DCED Contract from the Keystone Communities Program to the Mifflin County Industrial Development Corporation

The County was awarded funding from the Keystone Communities Program for costs associated with the demolition of Blacks Hospital. This project is complete. There were residual funds remaining in the amount of \$36,642. DCED is allowing the County to transfer funds to MCIDC for use of demolition of select buildings.

E. Amendment to the November 2, 2023 subrecipient Agreement with the Mifflin County Industrial Development, Inc. for the demolition of select buildings with the MCIDC Plaza – amended amount \$213,358.00

The County Commissioners and MCIDC came into a subrecipient agreement for \$250,000 for the demolition of select buildings within the Plaza. The original Grant amount has been reduced by \$36,642 and will go back to the County Funds for other eligible projects.
