A. Proclamation designating a new Mifflin County Bicentennial Tree

Proclamation Designating a New Mifflin County Bicentennial Tree

Whereas, Mifflin County celebrated its 200th Anniversary of its formation as a County in August, 1989; and

Whereas, as part of the Bicentennial Celebration in 1989, a Bicentennial Tree with an age of at least 200 years old had been chosen; and

Whereas, the original Bicentennial Tree had to be removed in 2025 because of natural causes; and

Whereas, in 1989, the Mifflin County Commissioners, within the original Proclamation dated August 31, 1989, stated that "the spirit of cooperation and unity exhibited in the celebration thus far continues through the official birthday on September 19, 1989 and <u>forever thereafter:</u>" and

Whereas, the Mifflin County Board of Commissioners wish to continue to recognize the spirit of the Mifflin County Bicentennial Celebration and the intent of the Board of Commissioners in 1989;

Now, Therefore, it is proclaimed that the American Sycamore tree located within the County-owned cemetery known as Potter's Field and being estimated to be at least 200 years old is designated as the Bicentennial Tree;

And, the County will perpetually care for the American Sycamore tree at Potter's Field as a symbol of Mifflin County's history and heritage.

Proclaimed this 16th day of October, 2025.

Motion was made by Commissioner Kodish to approve the proclamation. Commissioner Wise seconded the motion. The motion was unanimously approved.
