V. Warden's Report:

PREA Audit (Prison Rape Elimination Act):

The facility underwent a PREA Audit on July 24 through July 26, 2024. We received our Final Report on August 29, 2024 stating that we were in full compliance with this act. The facility exceeded three standards and met the remaining 42.

Maintenance:

- HVAC project was completed during the summer. The facility has seen as substantial improvement during all seasons.
- The intercom project is 98% completed with only a software update and some training remaining. This increased our security by adding video capabilities to the intercoms on facility entrance and exit doors.
