Mifflin County Library Executive Director Mirello thanked the Commissioners for the Proclamation. She was excited to share that the library has started the first Story Time in the newly renovated library. There are 8 sessions with 95 children. The registration was filled by noon on the first day.

Mifflin County Children and Youth Administrator Nicole Patkalitsky shared that in 2024, Mifflin County had 207 reports of abuse and 16 indicated cases of child abuse. Administrator Patkalitsky recognized the caseworkers and supervisors who respond to situations of child abuse.

Rebecca Wills, Public Training Coordinator from the Abuse Network, thanked the Commissioners for having her at the meeting and for signing the Proclamation. She also thanked the Commissioners for showing their support to survivors and for partnering with the Abuse Network to bring awareness that to the fact that sexual assault is a pervasive issue in Mifflin County. Coordinator Wills shared that the Abuse Network is hosting a social media event to bring awareness to Sexual Awareness Month.

D. Paula Hoffman, Director of Elections and Voter Registration - Election Update

Director Hoffman shared that she is in the process of proofreading ballots and preparing the mailings. The ballots need to be tested and approved. Some ballots were sent back for changes. There are currently 1,569 mail-in ballots. The goal is to mail ballots by the end of April and/or beginning of May.

The last day to make any changes to your voter registration or to register to vote as a new voter is May 5. The last day to apply for a mail in ballot or absentee ballot is May 13. Election day is May 20.

This grant needs to be linked to a taxing entity and Mifflin County has been authorized to serve as the host municipality for the RACP Grant.

 H. Payment Application No. 1 from Mid-State Construction, Inc. in the amount of \$59,961.28 for improvements to the Derry Township Senior Center

Armagh Township will have 1 year to complete this project.
