## I. Call to Order:

II. Approval of Minutes of January 16, 2025

- 1. Request from Sheriff Drayer
  - Increase the hourly rate of the Security Guards \$1.25 per hour.

3. Increase the range of the Director of Fiscal Affairs position

The new range is \$75,000 - \$90,000 per year. Increasing the pay range was suggested to make the salary more market driven to find quality candidates.

A motion was made by Commissioner Kodish to approve the increase. The motion was seconded by Treasurer Griffin. The motion carried.

4. Request from Nicole Patkalitsky, Children and Youth Administrator, to increase the Fiscal Supervisor's salary - \$5,000.00

The salary increase request is to bring the Fiscal Supervisor's salary to the previous salary level for the position.

Chairman Postal made a motion to approve the \$5,000.00 increase. Commissioner Wise seconded the motion.
